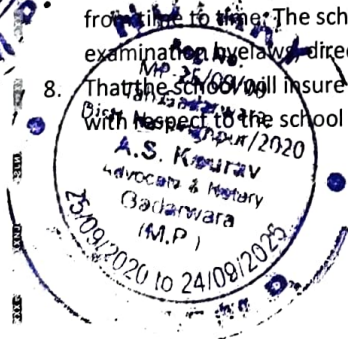
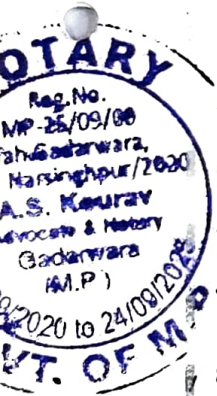
I Chandan Singh Son of Bhavani Singh age 40 (years), Secretary of

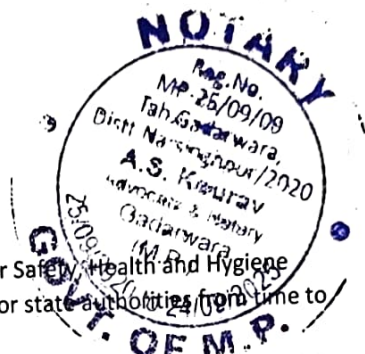
